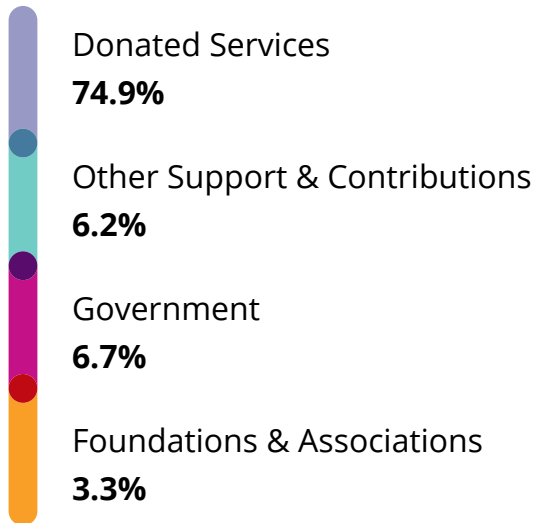

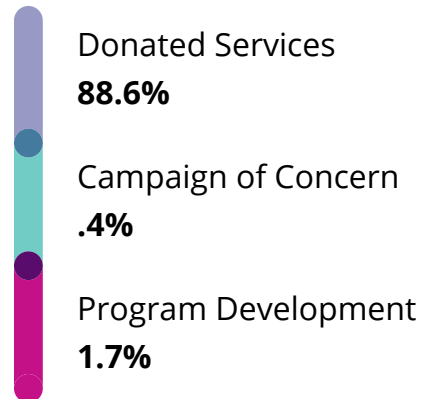

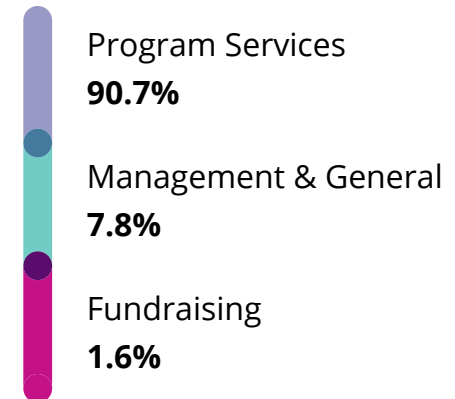
TOTAL SUPPORT & REVENUE
